## ASSIGNMENT OF THE RIGHTS OF ECONOMIC EXPLOITATION RELATING TO THE REPRODUCTION OF ARTICLES IN THE JOURNAL “PÓLEμος. MATERIALI DI FILOSOFIA E CRITICA SOCIALE”

I/(We), the undersigned \_\_\_\_\_, as author(s) of the article/essay entitled \_\_\_\_\_ (hereinafter referred to as the “WORK”), which will be soon published in the issue ..... of the journal *Pólemos. Materiali di filosofia e critica sociale*, published by DONZELLI EDITORE, under the title: “.....”, edited by .....

### DECLARE

1. that I am/(we are) the sole and exclusive owner(s) of the rights of economic use of the WORK and that I/(we) have the free availability and full and exclusive right to use it for educational, scientific and economic purposes;
2. that the content of the WORK complies in all its parts with the standards in force;
3. that the WORK does not violate, either in whole or in part, the rights of third parties, and that I/(we) undertake to indemnify the Publisher against all damages and expenses that may arise from its publication;
4. that, in the collection of the data relating to the WORK, all necessary authorisations have been obtained;
5. to cede to the publisher DONZELLI EDITORE all the rights of economic exploitation of the Work of which I am /(we are) the owner(s), without limitation of space and within the maximum time limits recognized by current legislation (currently 20 years) and with all methods and technologies currently existing and/or to be developed in the future. It is therefore meant to include the reproduction in any way and form, communication – including, by way of example but not limited to, also the rights of patrimonial exploitation by means of interactive digital channels (by any method currently known or to be developed in the future) – distribution, adaptation and converting of which the WORK is susceptible;
6. to cede also to DONZELLI EDITORE the right to translate, reproduce, distribute, communicate the text in any language, in any way and form, the rights of exploitation in/for advertising, the right to cede to third parties these rights, in whole or in part, for any reason, etc., without space limits and within the maximum time limits of protection recognized by current legislation and with all methods and technologies currently existing and/or to be developed in the future;
7. to waive the royalties deriving from the commercial exploitation of the magazine in which the WORK is published;
8. to be aware that the publisher may grant at its own discretion, to the individual author of each contribution published in the journal, the right to reproduce its article as a separate abstract or as a volume together with other writings, in other newspapers or journals or to make the article available online in digital format on public or private networks.

### ARTICLE EVALUATION PROCEDURE

Articles received undergo a double blind peer review process. A co-editor is identified from the scientific committee, the journal’s editorial board, or an external contributor. In addition, two external reviewers, to whom the article is sent for evaluation, are appointed. The reviewers’ opinions are communicated anonymously to the author by the editors/editors of the issue together with the decision taken by the editor-in-chief. Once the article has been accepted for publication, the secretariat contacts the author to define the final editing aspects.
